Chapter (Chapter I), International Harvester Collectors, Inc., and the State of Missouri as additional insured against all claims for injury or death to persons and injury to or destruction of property and may not exclude products-completed operations hazard coverage.

At least ten (10) days prior to commencement of the term of this Agreement, Vendor shall either furnish Rainprotection.net with a Certificate of Insurance signed by an agent authorized to sign for the issuing company or arrange to purchase the required insurance through the Rainprotection web page link on the Missouri Chapter 1 website. If said Certificate is not provided, Vendor shall not be allowed to participate in event.
